# HELP IS NEEDED ON PAINT AND WROUGHT IRON COMMITTEES



With Tom Magrann's resignation, the Board needs YOUR help. No one person can replace Tom Magrann. But we

desperately need volunteers to help with the yearly painting project and wrought iron issues. The Paint Committee oversees the color selection and actual painting of the street. The color selection process is assisted by Laurel Latshaw but she is unable to assume the chair position. This year the paint specifications will already be prepared by Tom, but more volunteers are needed.

The wrought iron chairperson is a volunteer who is contacted when Action receives a request for wrought iron fence or gate repairs are needed. In the past Tom Magrann has inspected the area and, if not an emergency, the requests are held until there are several to correct at the same time. Our vendor is then contacted to inspect and give a bid.

It was with great reluctance the Board of Directors accepted the letter of resignation from Tom Magrann effective December 31. As he stated in his letter, he is almost 85 years old, and he wants to move on and pursue his personal goals, one of which is to vacation with family and friends. As he put it, he

wants to see parts of the world he has never seen while he is still young enough to do so!

Tom has served this community for over 19 years beginning in 1988 when he and his wife Mary Jane moved to East Lake. Over the years he has served on the Board, the Finance Committee, and for as long as most of us can remember, has been the Painting Chairman and Wrought Iron Chairman. (Chairman usually meant a committee of one!) When anyone had a problem with paint or fencing, Tom was the man to call. Not the Board, not the property management company. Tom was the man who knew it all and did it all! He was recognized by the Board at the November Boat Parade Meeting for his devotion to his time-consuming roles for the Shores. No one can calculate the thousands and thousands of dollars he has saved the Association through his great diligence and attention to detail in procuring and recommending bids for painting and wrought iron repairs, as well as meticulous oversight of the actual work. His detailed reports, both oral and written, are legendary.

In true Tom Magrann fashion, he has volunteered to draft the paint specifications for the 2008 painting of Via Morena before his resignation and will be available on a limited basis to coordinate with whomever assumes his responsibilities. He will be sorely missed but the Board and the entire community wishes him the best. Tom recently underwent a hip replacement and recovered beautifully but he does have a couple of medical issues that are keeping him close to home right now. But knowing Tom, that won't keep him down for long. Thanks again, Tom, for your invaluable services and devotion to our community.

### PARKING AND STREET ACCESS DURING THE HOLIDAYS

The Board is very pleased with the 99% of residents who are now complying with the parking rules and regulations. The number of violations has dramatically dropped on all streets. Thank you very much for your cooperation.

Please remember. emergency vehicle access on the streets MUST BE KEPT CLEAR at all times, but especially during the holidays. Everyone is individually responsible. We live in very close proximity and our conduct has increased impact on our neighbors. It is not sufficient to have your guests leave a note which party they are attending and then allow them to double park, blocking access to the street and homes. That will not work in a real emergency - be it a medical or fire emergency.

Via Morena for the past several years has used a method that other streets should consider. They hire a couple of young people to monitor the end of the street. The cost is spread among all the residents on the street. The "monitors" allow vehicles to come in and park in the common areas as long as there are spaces available. After they are all full, the street is barricaded and vehicles are allowed in only to drop off handicap passengers (and goodies) and then must leave to park somewhere outside of the street. Guests of parties on the street are usually told of the parking procedures in party invitations.

Our current Customer Service Department has been enhanced with additional Service Specialists who are cross-trained to assist homeowners with a variety of requests and inquiries.


